Please discuss your opinion of the Minnesota Ave redesign that DDOT completed in 2023?

The DDOT plan for Minnesota Avenue has been a serious concern for Ward 7 Residents. Many constituents have had major concerns regarding the congestion of traffic daily navigating on Minnesota Avenue and the Benning Road Avenue corridor. There are too many small businesses, retail shops, and schools that surround Minnesota Avenue and to no avail the traffic has been a major concern for constituents. DDOT needs to be held accountable for making sure that the community supports their vision for redeveloping the transportation structure of what we consider as Downtown Ward 7.

Washington D.C. has failed in its goal to eliminate traffic deaths and serious injuries by 2024, what will you do to push the district to one day achieving the goal of eliminating traffic deaths and serious injuries?

Ward 7 has had to deal with traffic deaths for years. We have seen traffic deaths within the Benning Ridge Community. We have also experienced too many accidents on Southern Avenue and Fitch Street SE. ANC 7E while I was a Commissioner had been fighting for a traffic light to be installed. Just 2 months ago, we finally had a four way traffic light stop on Southern Avenue and Fitch Street. We call our efforts a success when there are so many people losing their lives that could have been prevented if the right safety measures were addressed. As councilman, I will continue to hold DDOT accountable in addressing the safety needs for the constituents of Ward 7.

Enforcement

What will you do to ensure the District is holding dangerous drivers accountable?

We must hold dangerous drivers accountable with warnings on their drivers license. Suspension of Drivers license. Constituents taking safe driving courses before have their driver's license reinstated. Dangerous drivers meeting with families they have affected while driving with no discipline. Dangerous drivers committing 100 community service hours in Washington, DC. As councilman, I would also hold dangerous drivers accountable by giving \$350 fines for their disregard of following traffic laws and rules provided by the Mayor and DC Council.
